(Babies, Preschool & Aftercare: Grade R – Grade 3)

1. RIGHT OF ACCESS & ASSUMPTION OF RISK

The right of admission and access to the premises of Besige Bytjie Akademie is strictly reserved at all times.

All parents, guardians, children, visitors, contractors, and any other persons entering the premises or participating in any activity related to Besige Bytjie Akademie do so entirely at their own risk.

2. GENERAL INDEMNITY & WAIVER OF CLAIMS

I/We hereby **waive, release, and abandon all claims** that I/we may have against:

- Besige Bytjie Akademie
- The owner, principal, management, staff, assistants, volunteers, contractors, or representatives

for any **injury, illness, accident, loss, damage, or death**, howsoever arising, including but not limited to:

- Indoor and outdoor play
- Educational and learning activities
- Aftercare supervision and homework assistance
- Transport, outings, excursions, or events
- Normal childhood risks, accidents, or illness

I/We hereby fully **indemnify and hold harmless** Besige Bytjie Akademie against any such claims.

3. IN LOCO PARENTIS

In the event of an emergency or when reasonably required, I/we nominate any authorised staff member of Besige Bytjie Akademie to act in loco parentis and to exercise reasonable discretion in the best interests of my/our child.

I/We hereby absolve and indemnify such persons and the school from any liability arising from decisions made in good faith.

4. TRANSPORT & EXCURSIONS

I/We acknowledge that my/our child may be transported by a vehicle owned, hired, or arranged by Besige Bytjie Akademie for school-related purposes, including excursions, educational visits, sports, or aftercare transport.

I/We accept that **while all reasonable safety precautions are taken, transport and excursions involve inherent risks.**

I/We indemnify Besige Bytjie Akademie against any claims arising from such activities.

5. ACTIVITIES & NORMAL RISKS

I/We acknowledge that:

- Children may sustain injuries during normal activities despite reasonable supervision
- Children may become ill or be exposed to contagious or non-contagious illnesses
